A BILL

To direct the Director of the Congressional Research Service to prepare a report extent of recidivism by individuals pardoned by the President under Presidential Proclamation 10887, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “January 6th Truth
5 and Transparency Act”.

1 **SEC. 2. REPORT ON RECIDIVISM BY 1/6 INSURRECTIONISTS.**

2 (a) REPORT.—Not later than 60 days after the date
3 of enactment of this Act, and every 180 days thereafter,
4 the Director of the Congressional Research Service shall
5 submit to the appropriate congressional committees and
6 make publicly available on the website of the Library of
7 Congress, a report on the extent of recidivism by individ-
8 uals pardoned by the President under Presidential Procla-
9 mation 10887 entitled “Granting Pardons and Commuta-
10 tion of Sentences for Certain Offenses Relating to the
11 Events at or Near the United States Capitol on January
12 6, 2021” (January 20, 2025).

13 (b) CONTENTS.—The report under subsection (a)
14 shall contain—

15 (1) a list of each individual who was pardoned
16 by, had their sentence commuted by, or with respect
17 to whom a pending indictment was dismissed pursu-
18 ant to the Presidential Proclamation referred to in
19 subsection (a);

20 (2) a list of each individual described in para-
21 graph (1) who has been arrested for, charged with,
22 or convicted of a criminal offense under Federal,
23 State, or local law, during the period beginning on
24 January 20, 2025 and ending on the date of the re-
25 port, including a description of each such criminal
26 offense;

1 (3) a list of each individual described in para-
2 graph (1) who has been involved in an encounter
3 with Federal, State, or local law enforcement, that
4 involved the use of force by a law enforcement offi-
5 cer against the individual; and

6 (4) any other information the Director of the
7 Congressional Research Service determines appro-
8 priate.

9 (c) APPROPRIATE CONGRESSIONAL COMMITTEES.—
10 In this section, the term “appropriate congressional com-
11 mittees” means

12 (1) the Committee on House Administration of
13 the House of Representatives;

14 (2) the Committee on Rules and Administration
15 of the Senate; and

16 (3) the Committees on Appropriations of the
17 House of Representatives and of the Senate.
