## **TAX CHANGES**

WHAT?	WHEN?
Tax cuts of up to \$30 million for ultra-wealthy households	<b>PERMANENT</b> Beginning in 2026
A temporary tax deduction of up to \$6,000 for adults 65 and older earning less than \$75,000	2025-2028 EXPIRES AFTER 2028 PRESIDENTIAL ELECTION
Instead of eliminating the SALT cap, restricts deductions to \$40,000. (SALT allows people with high state and local taxes to pay less in federal taxes.)	2025 - 2029 EXPIRES AFTER 2028 PRESIDENTIAL ELECTION
Eliminates \$200 tax on gun silencers	<b>PERMANENT</b> Beginning in 2026

Increases Covered California costs by over \$1,000 a year on average. *By ending financial assistance for working families (Health Care Tax Credits)	December 31, 2025
New paperwork requirements remove millions of Medi-Cal participants	January 1, 2027 AFTER 2026 MIDTERMS
Cuts to vital services at hospitals, providers, and clinics by raising costs on California.  *And limits CA's ability to pay for higher costs	As early as October 1, 2027 AFTER 2026 MIDTERMS
Raises Prescription Costs for Seniors  *By limiting Medicare price negotiations to fewer drugs	January 1, 2028 AFTER 2026 MIDTERMS
Low-income Medi-Cal patients could be charged up to \$35 copay each time they get care.	October 1, 2028 AFTER 2026 MIDTERMS

Cuts CalFresh benefits for every family	October 1, 2026
Increases CalFresh costs for California and our Counties by \$600 million, forcing cuts to public services or increased taxes	October 1, 2026
Cuts funding for CalFresh by up to \$2 billion, forcing CA taxpayers to foot the bill	October 1, 2027 AFTER 2026 MIDTERMS

### **RAISING ENERGY COSTS**

Raises costs for buying new or used electric and hybrid vehicles.	September 30, 2025
Raises costs for energy-efficient home upgrades like AC, insulation, and solar panels.	December 31, 2025
Cancels clean energy and manufacturing projects, ending 686,000 California jobs and raising energy bills by \$324 a year.	January 1, 2026 and onwards
