A BILL

To direct the Inspector General of the Department of Veterans Affairs to submit to Congress a report on the backlog of disability compensation claims submitted to the Secretary of Veterans Affairs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Administra-
- 5 tion Backlog Accountability Act of 2025".

1	SEC. 2. INSPECTOR GENERAL REPORT ON BACKLOG OF
2	DISABILITY COMPENSATION CLAIMS SUB-
3	MITTED TO DEPARTMENT OF VETERANS AF-
4	FAIRS.
5	(a) Report.—Not later than 180 days after the date
6	of the enactment of this Act, the Inspector General of the
7	Department of Veterans Affairs shall submit to Congress
8	a report on the backlog of disability compensation claims
9	submitted to the Secretary of Veterans Affairs pursuant
10	to chapter 11 of title 38, United States Code, pending be-
11	fore the Veterans Benefits Administration or the Board
12	of Veterans' Appeals.
13	(b) Matters Included.—The report under sub-
14	section (a) shall include the following:
15	(1) A description of the status of the backlog
16	described in such subsection.
17	(2) An assessment of how the Secretary is ad-
18	dressing such backlog, including how the Secretary
19	is recruiting staff to fill open positions within the
20	Department using authorities or amounts available
21	under the Honoring our PACT Act of 2022 (Public
22	Law 117–168).
23	(3) An assessment of the effect of any reduction
24	in staffing at the Department since January 20,
25	2025, affects such backlog.

1	(4) An assessment of how such backlog affects
2	the average amount of time claimants who have sub-
3	mitted disability compensation claims pursuant to
4	chapter 11 of title 38, United States Code, wait for
5	the Secretary to adjudicate those claims.
6	(5) An assessment of how the Secretary is pre-
7	paring to address the predicted 50 percent increase
8	in such claims resulting from the Honoring our
9	PACT Act of 2022 (Public Law 117–168).
10	(6) An overview of how new technologies, such
11	as automated decision support technology, have con-
12	tributed to the reduction of such backlog.
13	(7) Recommendations by the Inspector General
14	to further reduce such backlog.
